# Insurance4Truckers Privacy Policy

## 1. Information We Collect and How We Use It

Upon receiving your opt-out request, we will send you a one-time text message confirming your decision to unsubscribe. No further messages will be sent to you after this confirmation, excluding any messages necessary for the completion of ongoing transactions or as required by law.

We implement measures designed to protect your personal information from unauthorized access, use, alteration, and disclosure. However, the transmission of information via the internet and mobile platforms is not completely secure. We cannot guarantee the security of your personal information transmitted through our text messaging service.
